1. How We Collect and Use Your Personal Information

Purpose	The Personal Information We Collect

To fulfill or process orders;	<ul> <li>Identity and contact information such as name, phone number and shipping address, as well as financial information or payment account information, for delivery, returns, refund, sales tax determinations, and payment operations;</li> <li>Transaction details, such as return and refund details, gift card number, and order history, in our Services, in order to fulfill basic functions, including processing your payment and return requests, and keeping you informed of the order status and shipping logistics;</li> <li>Location data at an IP address-based level, to tailor your experience in terms of displaying the appropriate local website, language, or user experience.</li> </ul>

To undertake marketing, advertising or other promotional activities;	<ul> <li>Contact information, such as phone number and email address, for telemarketing and email marketing purposes;</li> <li>Non-directly identifiable device identifiers, operating system information, and cookie information, to direct and measure the effectiveness of the advertising we offer;</li> <li>Data about how you engage with our Services, such as browsing, adding to your shopping cart, saving items, placing an order, and returns) for market research, statistical analysis and the display of personalized advertising based on your activity on our site and inferred interests;</li> <li>Contact and identity information, such as name, email address and phone number, when you voluntarily enter into a competition, market survey, event or other marketing campaigns organized by us;</li> <li>To share your personal data with third party advertisers.</li> <li>Name, email address and/or phone number if you enter into a promotion or program, such as the SHEIN VIP program via the Services or through a third-party platform ("Promotion").
