### POCO Launcher User Agreement

POCO Launcher (hereinafter referred to as the "Product") is a mobile phone operating system designed, operated, and owned by Xiaomi Inc., a company incorporated under the laws of the People's Republic of China with registered offices at #6, 6th Floor, Building 6, 33 Xi'erqi Middle Road, Haidian District, Beijing 100085 China, and its affiliates within the Xiaomi Group (collectively, "Xiaomi", "we", "our", or "us").

Please read this Agreement carefully and fully, including but not limited to the sections on Disclaimers and limitation on liabilities and Indemnification, and understand and choose to accept or not to accept this Agreement. Minors should read this Agreement accompanied by a legal guardian. Xiaomi may suspend services or stop providing the Product to you if you do not comply with our terms and policies. By your account creation, sign-in, and usage of the Product and its services, you are deemed to have read and understood, and agree to accept and be bound by, the terms and conditions of this Agreement as well as other agreements and rules in connection with this Agreement.

Your acceptance of this Agreement constitutes your voluntary acceptance to be bound by all terms, including acceptance of any modifications made by Xiaomi to any terms of service at any time. This Agreement can be updated by Xiaomi at any time. Once the updated Agreement terms are announced, they will replace the original terms without further notice. Users can check the latest version of this Agreement in POCO Launcher. After Xiaomi modifies the relevant terms of this Agreement, if the user does not accept the modified terms, they should stop using the Product immediately. The User's continued use of the Product will be regarded as acceptance of the modified Agreement.

#### 1. About POCO Launcher

POCO Launcher is a lightweight, high performance smartphone operating system from Xiaomi. It features personalisation settings and a complete set of security solutions to ensure a private usage environment for users. The following are some of the main features of POCO Launcher:

1.1 Apps and app management

POCO Launcher provides users with a variety of ways to organise and search for apps on their devices. All apps are stored in the App drawer, so the Home screen stays simple and tidy. Users also receive smart recommendations to install apps they might need. Recently installed and used apps are displayed in the top part of the App drawer. Apps are automatically grouped according to their categories, but alternatively can be grouped by the color of their icon.

#### 1.2 Home screen personalisation

POCO Launcher offers multiple options for Home screen personalisation. During the initial setup, users can select wallpapers according to their preferences. They can also browse, download, and use different themes and wallpapers in the Xiaomi Theme Store. Themes also allows users to replace existing icon packs with other designs. Users can filter and drag apps to

rearrange them.

1.3 Basic system features

POCO Launcher provides users with convenient features such as a clock widget displaying the time and date, shortcuts, and message reminders.

1.4 Privacy and security

Among the privacy and security-related features of POCO Launcher, there is one that allows you to hide specific apps so that only you can see and use them.

2. Third-party products and services

2.1 When using this product, third-party products or services can be accessed by:

Integrated links: Search suggestions embed the links into services provided by third parties in order to provide the corresponding services to the user.

Direct links: When users search for apps on their device, app recommendations provide links to third-party app markets in order to provide the corresponding services to the user.

Embedded third-party services: In order to support some Product features, we embed thirdparty services. These provide services such as recommendation of personalised ads. Use of system interfaces: Some Product features require the use of system interfaces to provide services to users; for example, uninstalling apps.

3.1 Some of POCO Launcher's services require connection to Wi-Fi or mobile data to be able to work properly. You shall bear all related communication fees as well as fees from third-party carriers and service providers. If you participate in any activities which contain value-added services, you should contact your carrier for more fee-related information.

# 4. Terms of use

4.1 You may only use the Product in accordance with all applicable laws and to utilise the services that may be offered on the Product. You agree not to use the Product for any purpose that is unlawful, illegal, or forbidden by these terms or any applicable laws. Xiaomi may, at its sole discretion, at any time and without prior notice or liability, suspend, terminate, or restrict

We have the right to suspend, at our sole discretion or determination, any content that violates the laws and regulations in any jurisdiction or the terms of this Agreement; that infringes upon, prejudices, or threatens any right or safety; or that impersonates others. We also retain the right to take proper legal action, including but not limited to removing any illegal or infringing content, suspending the qualifications of violators and saving relevant information and reporting to relevant authorities based on applicable laws and regulations.

4.3 Users may not undertake any of the following actions:

4.4 All information provided by you will be governed by the terms of the Privacy Policy. The terms of the Privacy Policy form part of this Agreement, and will be binding on you at all times.

# 5. Intellectual property rights and license

5.1 Xiaomi has legal rights to the information contained in this Product, which is protected by intellectual property rights or related laws and regulations. Such rights include but are not limited to ownership, intellectual property rights (whether or not such rights have been registered, and whether or not they still exist in the world anywhere) and other related interests.

Without Xiaomi's written permission, no one may copy or use this Product for other purposes (including but not limited to monitoring, copying, disseminating, displaying, mirroring, uploading, or downloading through any robot, web crawler, or other program or device).

5.2 Xiaomi grants you a limited license to access and use this product for personal, noncommercial use. ### 6. Force majeure

6.1 Neither Xiaomi nor you shall bear any liabilities for any consequences resulting from failure or delay in performing any obligations under this Agreement due to any event beyond their reasonable control ("force majeure events").

6.2 If such a force majeure event continues, either party reserves the right to terminate this Agreement or suspend the performance of any obligations hereunder and resume performance after a certain respite period. Both parties shall take reasonable steps to end the force majeure event or find a solution such that they can continue to perform their obligations if the event continues.

# 7. Disclaimer and limitation of liabilities

7.1 The Product and all content therein are provided on an "as is" and "as available" basis without any representation or warranties, express or implied except otherwise specified in writing. 7.3 To the maximum extent permitted by law, you waive, release, discharge and hold Xiaomi, its affiliates, and each of their directors, officers, and employees, harmless from any and all claims, losses, damages, liabilities, expenses and causes of action arising out of your use of the Product.

### 9. Applicable laws and dispute resolution

This Agreement shall be governed and construed in accordance with Chinese laws. All disputes arising out of or in connection with this Agreement shall be submitted to a court with jurisdiction in Haidian District, Beijing for resolution.

### 10. Miscellaneous

10.1 If some terms of this Agreement are invalid or unenforceable for whatever reason, the remaining provisions shall still be valid and legally binding on you and Xiaomi.

10.2 This Agreement may be provided in Chinese, English and other languages. If there is a conflict between the versions in different languages, the English version shall prevail.
